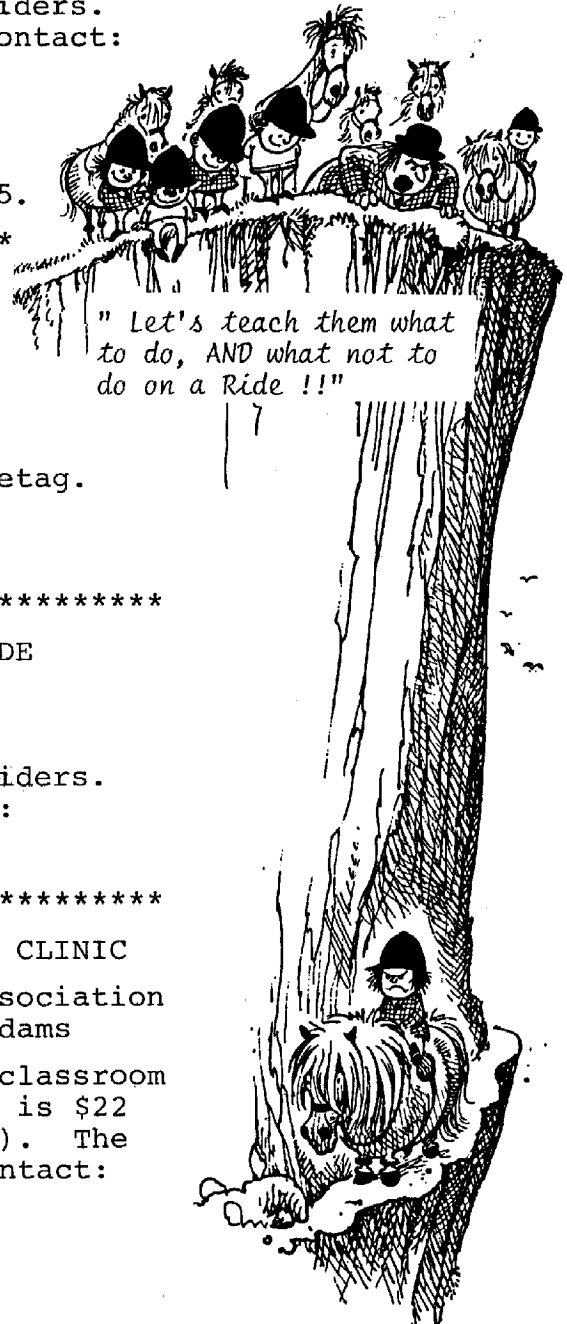

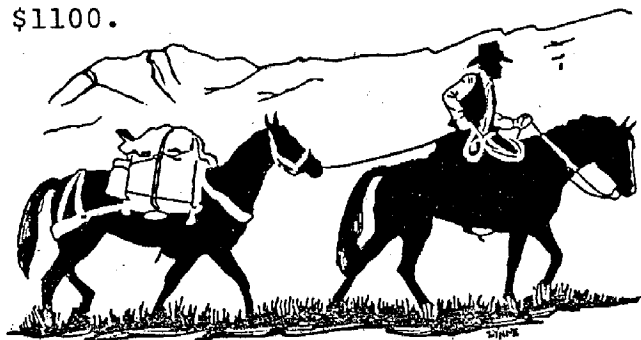

The 1986 NATIONAL NATRC CONVENTION was held in San Francisco on Feb. 6-9. The theme of this year's convention was "Where It All Began" and "To Ride Is To Win".

Ike Mosgrove was approved by the Nat'l. B.O.D. to complete Violet Peek's term on the B.O.D. (thru 1987). Other Reg.3 B.O.D. members that were present were Dr. Gene Naugle, DVM and Judy Cumberworth.

The rule regarding OPEN MILEAGE will be clarified in the 1986 Rule Book, indicating that in steep or rugged terrain the distance be shortened or riding time extended.

The B.O.D. approved ELMER'S BANDIT, owned, ridden and nominated by Mary Ann Woods from Independence, MO to be the first horse to be entered into the NATRC HORSE HALL OF FAME....having met all the requirements, and well over the 125 minimum points required.

Region III judges Gene Naugle, DVM and Judy Cumberworth were members of the Rider/Judges Panel, and Bill Cumberworth was a member on the Management Panel. You will be reading about the other fine speakers in the upcoming issue of HOOF-PRINTS.

Next year's NATIONAL NATRC CONVENTION will be held in North Carolina. Then, in 1988, Region III will be hosting it.

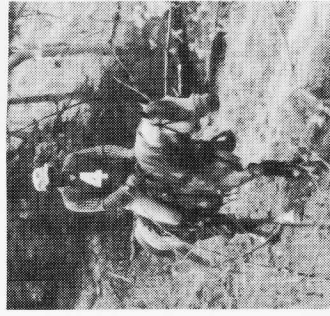

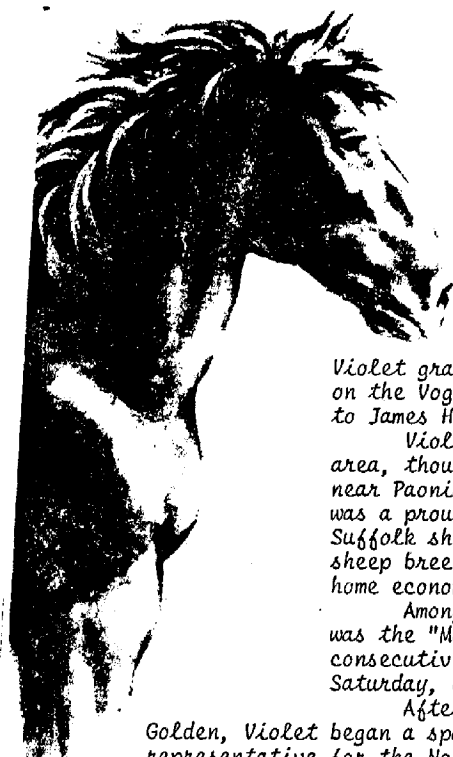

## Goodbye to our dear friend, Violet Peek

VIOLET GRACE VOGEL PEEK died at home in Golden, Colorado on February 5th, 1986.

She was born of Gilbert F. and Marie Harvey Vogel on November 8th, 1917 in St. Louis, Missouri.

Violet graduated from Garo High School in 1934 after her childhood on the Vogel homestead in South Park, Colorado. She was married to James H. Peek on June 1st, 1939 in Colorado Springs, Colorado.

Violet's home was, for many years, located in the Denver area, though the Peek family did own and operate a working ranch near Paonia, Colorado from 1960 to 1971. On the ranch, Violet was a proud and able shepherdess of her large flock of purebred Suffolk sheep. Being an excellent seamstress and a professional sheep breeder, Violet was a 4-H Leader in sheep production and home economics for ten years from 1957 to 1967.

Among Violet's many accomplishments in this life, Violet was the "Mother of the Week"; her seven children were born, consecutively, eldest to youngest beginning Sunday, and ending Saturday, over a period of eleven years.

After a move back the Eastern Slope in the foothills above Golden, Violet began a sparkling equestrian career. She was a public relations representative for the North American Trail Ride Conference, a national organization for competitive trail riding. Violet was voted into office several times, and held the position of Regional Board Member for three years; and she was a National Board Member for two years. Violet sponsored and was Chairwoman of the Rocky Mountain Competitive Trail Ride for three years. Being a competitive and excellent equestrian, Violet won numerous regional and national awards. She was the recipient of the highest national award of all age categories presented: The President's Cup in 1978 at the age of 60. Violet was, the same year, awarded the Colorado Sports-Woman of the Year. Violet's most recent award given to her and Jim, as a couple, was the NATRC/Region III 1984 Appreciation Award. This past summer of 1985, Region III presented to Violet, a Perpetual Scholarship in her name for aspiring veterinary and animal science students.

Violet was also an accomplished artist and a member of the Wheatridge Art League and Foothills Art Center.

SHE IS SADLY MISSED AND GREATLY LOVED BY ALL WHO KNEW HER.

Violet Grace Vogel Peek is survived by her husband, James H. Peek; her mother, Marie Harvey Vogel, Denver; two sisters: Elizabeth (Betty) Vogel Ellis of Omaha, Neb., Hazel Vogel Pearsall of Norfolk, Virginia; a brother, Eugene Vogel of Phoenix, Ariz., and Denver, CO; two daughters: Virginia Marie Peek of Golden and Karen L. Peek Land werlen of Indianapolis; and five sons: David M. Peek and wife Linda; James G. Peek and wife Mary; Clyde E. Peek and wife Roberta; Daniel W. Peek and wife Patty; Robert H. Peek and fiancée Joanne Kleewein. Violet is also survived by fifteen grandchildren and four great-grandchildren.

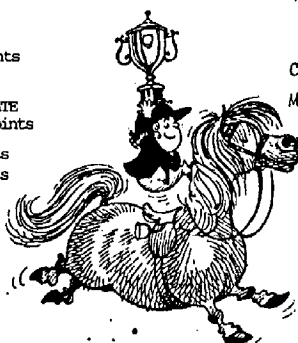

## 1986 President's Cup

Winner!

Congratulations to....

Milne Parish and his  
 horse, Mahra Khan!



How excited we are for our very own Region III member, Milne Parish and his horse, Mada (Mahra Khan) for winning this year's highest National honor in competitive trail riding, the 1986 President's Cup!

Milne and his mare won 290 points (way ahead of his nearest competitor) in 22 Rides from March thru November of 1985. Most of the Rides were @ 60 miles, but the last two were held in Georgia and they were 90 miles each. That is a total of at least 1,380 miles in one season, folks!

Milne was also awarded the NATRC High Point Award for Region III 1985 and they won the Van Vleet Memorial Ride Sweepstakes Trophy and High Point Half-Arabian Trophy on that Ride.

Milne received the President's Cup at the NATRC National Convention in February. Now that he has brought the Cup home with him, he would like to share his story of a successful season with all of us members:

In 1981, my wife and I began NATRC competition as a way to get more enjoyment out of our horses. My 7/8th Arabian mare Mada (Mahra Khan) and I competed in six Rides in 1981, getting a fourth place tie in Region III Open Division Lightweight Class with her stablemate, Pokee.

In 1982 & 1983, I rode Pokee and let Mda run in the mountains. After the first Ride in 1984, Pokee reinjured an old wound. I brought Mada out of the mountains eight days before the Cavalier Ride to replace Pokee. In a class of 17 heavyweight riders, she placed fourth. Three weeks later, in Region VI, she won sweepstakes. The next weekend in Wyoming, she sweepstaked again. So, we were off to a National Championship. Mada ended up placing second overall in Region III and sixth nationally.

In March 1985, we went to Region IV for two rides. At Woodfire she placed second and at Region IV Benefit she got a first. The weather was just beautiful Wednesday and Thursday before the Region IV Benefit Ride, but on Friday it started raining and it rained five inches. A stream the horses could step across on Thursday they had to swim on Sunday. But what a great job John Webb, the Deans and all those other fine folks did, making the Ride run smoothly in spite of Mother Nature.

In the next seven consecutive Rides, Mada had a first in the first Ride and a first in the seventh Ride. By then I had decided to see how far we could go! My next Ride was at Cottonwood Canyon, our third Region VI Ride of the year. I was in Regions IV and VI so much, people thought I lived out there. The people treated me so nice I just kept going back!

Never having been in the southeast, I decided to go to North Carolina in mid-September for a three-day Ride in the Great Smoky Mountains. What a beautiful country! Through hardwood forests and up and down mountain trails. Everything was going fine until I made a wrong turn on the trail, riding six miles before I realized I was going the wrong way. We got back to where I made the wrong turn only to find the drag riders had pulled all the ribbons by that time. The park ranger pointed me in the right direction, and by checking horse tracks at the forks in the trail, I managed to make it to the lunch site about one hour and 45 minutes late. Management told me I could not make up that much time, but they did not know Mada. She went up one side of the mountain and down the other at a ground-eating trot without breaking stride, passing one horse before the final P&R. She came out of the P&R with a nine and three.

From North Carolina I headed for Missouri for a Ride, stopping at Jack Sledge's place for a few days before going to the Cole Creek Ride. This was a first-time Ride, run beautifully, with a clubhouse for briefings and a river to swim your horse in. From Cole Creek it was to the Angelina Ride in Texas. From Texas, back home to give Mada a break while I went elk hunting.

After hunting, it was back to Oklahoma where congratulations are due to the Tate family. They have to be the 1985 NATRC Family of the Year. Rip took first in Heavyweight Horsemanship, Linda took first in Lightweight Horsemanship, and Ripley took first in Junior Horsemanship.

My final trip for the season was to Georgia. First was the 2-day Spotacular Ride in a forest with the trees in all their fall colors, then ending the season with a AA-Ride at Hutchins Mountain where Mada placed first. What a great way to finish the season, proving again what a really great horse she is! It was her fortieth NATRC Ride and she was never pulled from any of them. There was never a time when she was not ready to go out on the trail the next day after a Ride. She always has the willingness and stamina to keep going and do all you ask of her.

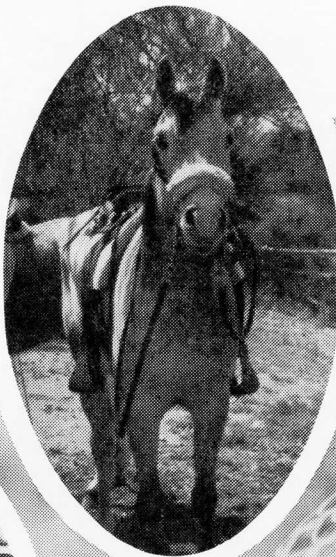

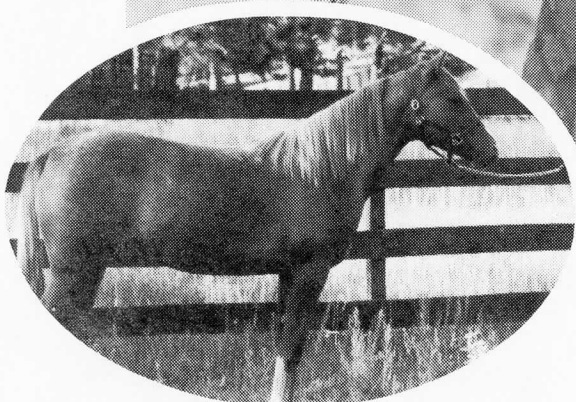

# THE HORSEMEN'S EXCHANGE

Our rider was born in Jackson, Wyoming, where his folks homesteaded, moving later to Colorado and attending Denver schools.

He spent his summers on SILVER FOX-CATTLE RANCH in Gilpin County, riding horses (bareback) all over that area. Another move took him to a larger cattle ranch in the Larimer County foothills.

He attended Colorado A&M (now CSU) majoring in Range Management.

During WWII, he trained with the 10th Mtn Division @ Camp Hale, here in Colorado, then on to Italy via the staging area at Camp Swift, Texas, near Austin, here he met a young Texas U co-ed, who he married after the war. At this time he returned to his job with the US Soil Conservation Service in SE Montana, with later transfers to Briggsdale, CO (now Pawnee National Grasslands) to Kremmling, and finally to Craig, where they bought their "little moonlighting Ranch" and started their Arabian herd. He gives his wife credit in being instrumental in selecting the Crabbet mares to compliment the Kellogg colt, purchased from Remount while at Briggsdale. It is the progeny of these horses that eventually made trail riding such a pleasant adventure for him.

Our rider, retired from the SCS in 1974, and has been giving full attention to the ranch since.

His first introduction to Competitive Trail Riding was in 1976, when they helped on P&R crews on the IAHA National Ride in Grand Mesa, and the next year tried a few rides himself, and continued ever since.

They are trying to phase out their ranching operation and move to a milder climate with just a few horses, where winter conditioning does not have to be done in knee deep snow.

You can read the January 1986 Western Horseman, which ran a very nice article on our rider and his wife with details on their horses and trail riding.

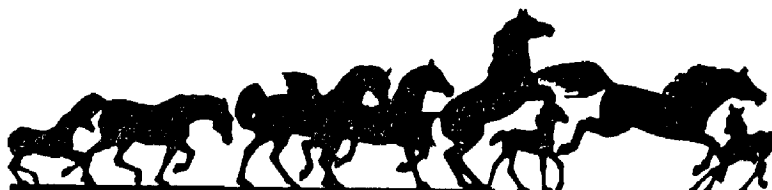

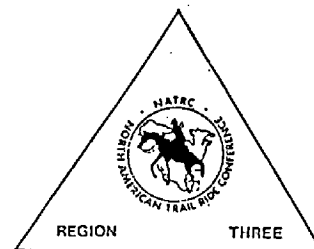

- Elk Creek Law Suit....Alan Dorr sueing Vonnie Davis for \$250 as agreed fee for being Apprentice Vet on Ride...it is not NATRC policy to pay Apprentice Vet Judges.
- Publicity discussed: Newsletter ad rates were approved; discussion on using "HORSES WEST" as official Reg.3 magazine; article on the McKinstry family in Jan. 1986

"WESTERN HORSEMAN" & article on Ike Mosgrove in same issue, articles to be contributed regularly to this magazine and "ARABIAN HORSE EXPRESS"; motion passed that non-member fee for Reg.3 Newsletter is \$8.00; Stock Show booth a success and worth doing again, motion passed to approach Nat'l.
