

Being a member of the Regional Board is an opportunity for members of Region III to be of service to their sport and to have an opportunity of contributing toward the improvement and success of our Region.





Based on open high average horsemanship scores

On my priority list of things which make life worth living are activities with a high "fun factor," like riding NATRC. Reebok says, "Life is short, play hard" and this just happens to be my M.O. which fortunately has not yet caused me to experience any prison time . . . lets ride!

I now compete on the offspring of my former mount, two time National Champion Sabrina Bar a/k/a Bitch Woman. My current mount Kristabar, an eight year old half Arab, is a native New Mexican, who I broke last season. Several hundred miles later she is showing possibilities of filling her mom's shoes.

We all hope to begin a new season with an easy, white-bread-type ride. This year's reality check produced sleet, snow and trail speeds that threatened to cause nose bleeds. The new Perry Park ride couldn't have been more fun if we had tried. That group of yahoos made the trip worthwhile, even though an accident put my mare's leg in a cast for three weeks thereafter. The Colorado Trail ride was absolutely infallible due to management expertise. Unfortunately, prior to the ride, I had a lapse of common sense (and a powerful thirst), drank from a mountain stream and contracted a case of giardia. You've not lived until you have contracted a full-blown case of "beaver fever!" The Top of the World ride is a ride I look forward to - a good ride and great people. I was having a really good time ... before I got lost. Forty-five minutes late and hurrying to catch up, I overheated and succumbed to heat stroke. Lying on the ground, short of coherent thoughts my buddy rode up and suggested I get back on my horse and follow. As I had little time and many more miles, I did. Loping along, I was unseated when my head impacted with a low-hanging branch. I was sure I had ducked! More time was wasted searching for my hat which still contained most of my ponytail. I've never seen such a good-looking finish line!

Thinking back, it seems there was something outstanding about each ride I attended. The National Convention in San Jose, Calif., was no exception. Lonnie Smith, my S.O. and I set out from Aztec, New Mex., to Sacramento, Calif., a week early to visit my family. Then, after borrowing a vehicle, we proceeded to the convention via the "California freeways." Boy howdy, we were doing really well too. Got off the right exit and drove to the exact building - all on the first try! Pulling to the curb, we went in to check the luggage before looking for parking. We were somewhat confused by the layout of the lobby. Walking up to the front desk we asked where to check in. The reply was "Why don't you go to the hotel next door - you're at the bank." A small faux pas. Other than dragging the 60 lb. "Polly" award through airport terminals in what appeared to be a small casket, the rest of the trip was without incident.

Having competed since 1980, I look forward to each new season as another adventure. And yes, if you are wondering, I am blonde. - Terri Roberts

Region 3 marks loss of long-time friend







REGIONAL BOARD HIGHLIGHTS

August 29, 1992 at Judd and Linda Adams' beautiful Boulder, Colo., home. Board members and guests present: Jill Talbot, Ike Mosgrove, Frank Bowman, Stacy Bowman, Laurie Butterfield, Kathryn Utke, Susie Witter, Pat Jubb, Mary Lou McManaman, Dean Schrader, Neal McKinstry, Dee Overholt, Joyce Calhoun, Cindy Wright, Judd Adams, Linda Adams and Lisa Sowell.

The meeting began with a review of the minutes of the May 2, 1992 meeting. Note changes to minutes: name McFarland to McDonald, Judy Wise's name spelled incorrectly. Delete the word year in regard to engraved plaques and replace with mileage/points. During review a discussion took place pertaining to the CP division. The minutes were approved as corrected.

Membership report – Ike Mosgrove –

An updated membership list was passed around. Judy Miller is assisting with horse/rider mileage according to Susie. Pat voiced her concerns over whether people should be listed as members pending confirmation from national. A membership history was passed around and Jill encouraged us to remember to help promote new riders. Discussion about having so many workers who do not want to become members. Is this because of fee cost, particularly the national fee? Susie was curious about how ride managers were taking care of the vest deposit money retained at their rides. Shouldn't the destination of where the money was going be indicated on a sign or something, instead of a verbal commitment? A proposal to the national board dated Nov. 4, 1989 was brought out and indeed there was similar verbiage in regard to fund-raising for national board. There was also mention of free ride raffle tickets being sold to raise money. This had been voted on and approved by the national board at that time. Suggestions/options were discussed about where vest deposit money should be put including returning the money to the regional board for redistribution. Susie motioned that deposit money be: 1. Refunded to rider; or 2. Ride manager can take said money and put into a clearly specified fund; or 3. Put the money into the general funds account; 2nd/approved. This policy will be included in the ride managers' packets. Discussion to increase Region 3 membership dues. After much discussion, the motion to increase all types of memberships by \$5 (family = \$18, senior = \$15 and junior = \$13) was 2nd/approved. Another motion to increase the Region 3 ride fee from \$4 to \$6, after some discussion; 2nd/approved. Three dollars will go to the national board fund and the other three will help bolster our general funds account.

Newsletter – Lisa Sowell –

Discussion of what still needs to go into the upcoming fall issue. There was mention of creating a special membership for workers, hold for next meeting agenda. (Anyway, back to newsletter.) Suggestions for additional articles and need to have ride managers send in their ride write ups. Some members present thought that Hoof Print should cover Region 3 more thoroughly, especially the ride results. Items have been forwarded to Ruth in the form of our newsletter for her perusal, plus the odd occasional story.

Note to ride managers ... the board has made a policy to specify that vest deposit money be handled in the following manner: retained by rider, placed into fund as clearly specified at ride or placed into the general fund account.

Membership lists/labels – Pat Milltzer (by Jill Talbot) –

Laurie motioned that Pat should be given 100 worker points for her yearly efforts retroactive to when she first started them 5 years ago; 2nd/approved.

1992 Year-end seminar – Mary Lou McManaman –

A list of prices, agenda and program was distributed. A discussion followed on having vendors and then dealing with hotel and city licenses. Mary Lou would like today's attendees to donate door prizes at seminar and also to think about ideas for a big-ticket donation drawing item. More discussion on the speakers and their schedules, election and when to hold the board meeting. A big thanks to Mary Lou for her efforts.

Colorado Trail Committee – Kathryn Utke –

First phase of trail maintenance went well, however we still need to go up and do additional bog and creek crossing work. This will be a little more difficult, and will require more volunteers to accomplish the task. Arrangements will be made for next year. Kathryn mentions again that if we continue to show little or no support for our section of the trail that we should consider giving up our portion.

Lunchtime with Adams' Catering (yum yum!)

Publicity/clinic – Frank and Stacy Bowman –

Will work on preparing the Region 3 booth for the national convention in Lexington, KY. Have had some articles published in local papers. Discussion of display/booth space at the National Western and Colorado Classic.

Historian – Judi Tobias –

Everything status quo, would like anyone out there with extra NATRC-related pictures to please send them for the photo albums.

Judge's committee – Susie Witter –

Discussions of judge selections at remaining rides, this committee has worked out well in its capacity. Ideas for recruiting more vet judges and how to go about doing it were talked about.

Bylaws – Jill Talbot –

Revisions and/or amendments to the following bylaws, order of business, standing rules, horse and rider awards, and worker awards voted on and approved: Article III, Section 6. The President shall appoint a Nominating Committee for the annual election at least 90 days before the annual meeting. This committee shall solicit candidates from each district for district representatives according to the election procedures listed in the Standing Rules. Article VII Section 6. By a vote of two-thirds of the Board of Directors present and voting, any member may be removed from membership as provided under Article I, Section 4 for valid cause. Article XI Order of Business Section 1. Change format to one presently used a board meetings (see agenda for summer meeting as an example). Standing Rules Region III Management 1. Riders fee shall be \$6.00 per rider for each ride. Three (\$3.00) dollars of this money shall support the National Board members travel expenses. Three (\$3.00) dollars shall go for Region III General Fund. 4. The Region III slide show and videos may be used by members free of charge or by outside groups for a fee of \$10.00. Moneys shall be earmarked for replacement. 5. Region III will not rent vests and stethoscopes to other organizations. Horse and Rider Awards 8. Members who do not renew their memberships by Mar. 1 of the year will have to pay an additional secretarial fee of \$15.00 in order to have their mileage and points calculated by the point secretary. Worker Awards 3. Add to points list (after Membership Chairman) Mailing Labels 100 points.

Ride Book – Sena Fitzpatrick –

Sena and Don Grieser are looking to relocate.

National Board Report – Laurie Butterfield –

Region 3 publications well-received by national board. Regions are encouraged to plan something for National Trail day, June 5, 1993. Discussion of ideas about what to do with the open junior division including offering three weight divisions in open, or allowing juniors to compete in the regular open classes. Members present felt most strongly about allowing juniors the option to compete in the regular classes, she will take this opinion to the national board. High mileage horse or rider medallion program as follows: 4,000 miles earns bronze medallion; 7,000 a silver; 10,000 a gold and 15,000 a gold with diamond medallion. President's Cup criteria proposal – points for first 16 rides started included four rides to be out of region. Tie would be broken based on first and second places, not sweepstakes. Members present had consensus for Dean to take to national board.

Safety Rider program – Jill Talbot –

Receiving good support for guidelines. Discussion of articles regarding accidents written about in Hoof Print. Jill would like to research insurance more thoroughly as NATRC's policy is a general liability policy only. She would like to see a mandatory M.D. or clinic on call for rides. More suggestions for horse first-aid kit and use of walkie-talkie and/or cellular phones for emergencies. Discussion of ways to get better help if needed into remote areas of rides. Idea of offering an emergency card in rider packets for rider to voluntarily fill out and carry on person during competition. Dee would like to see some tightening up of certain guidelines for safety rider leader and a few other guideline improvements. Another discussion followed about ride managers being members.

Old Business –

Ride book made a \$119.19 profit (great!) Other regions are interested in using our Youth Manual, so Jill is getting a quote from her printer on another press run and we need to figure in a possible profit. Will likely hold until after Jan. 1 to re-print.

New Business –

Walkie-talkie sets, keep ideas or good deals for purchase of sets in mind. Mary Lou is sending year-end seminar invitations to all national board members. Jill received a thank you letter from the Horsetooth ride for her help and thought it might be nice for ride managers to keep this gesture in mind for their volunteer workers. Crazy Horse Resort in Buena Vista, Colo. area has contacted national about the possibility of offering their area and nearby national forest trails access for a ride. Gloria Becker is sending them information about NATRC.

The next regional board meeting is scheduled for Nov. 8, 1992. It will be a breakfast meeting and will begin Sunday at 8:00 a.m.

Meeting adjourned at 5:20 p.m.

National horse and rider high mileage awards – new medallions will be offered at the 4,000, 7,000, 10,000 and 15,000 mile level.

BITS AND PIECES

Region 3 renewal/newsletter subscription

If you haven't renewed your Region 3 membership, the cutoff date for receiving the *Region Three Newsletter* will be June 1 of the same year. National (but not Region 3) members will receive two complementary newsletters only unless they join Region 3.

Eligibility for Region 3 year-end awards

All national NATRC members who are dues-paying members to Region 3 NATRC are eligible for regional placings and awards.

Requirements:

Open horses and riders must enter three (3) rides per season and accumulate a minimum of 30 points to be eligible for year-end placings. Open horses and riders will be eligible for the Ruth Tyree High Average Horsemanship and Ken Burkdoll Combined High Average Horse/Rider awards if they enter a minimum of six (6) regional rides. All rides started will be counted.

Competitive Pleasure horses and riders must enter two (2) rides per season and accumulate a minimum of 20 points to be eligible for year-end placings. Competitive Pleasure horses and riders will be eligible to compete for the High Average Combined Horse/Rider award but must enter a minimum of four (4) rides per season. The top horse in Competitive Pleasure shall be considered as a sweepstakes horse within the class and shall receive 2 additional points as done in the Open and Novice divisions. Novice horses and riders must enter two (2) rides per season and accumulate a minimum of 12 points to be eligible for year-end awards.

Horses and riders receive 4 points for ride completion and a sweepstakes horse receives 2 points (18).

Memo to ride managers

Rides are requested to send the results of a ride to national within two weeks after the ride. Ride results Region 3 rider fees should be sent at the same time to the point chairman.

Verification of points and mileage

The point secretary keeps all Region 3 members' points and mileage each year. You are welcome to verify your points with the chairman by Oct. 15 of the current year, otherwise you must accept the points as calculated by the point secretary. Region 3 NATRC members who have not renewed their memberships by June 1 of each year will have to pay an additional \$15 secretarial fee if they wish to have either their horse or rider points and mileage recorded.

Breed award eligibility

To be eligible for breed awards at each ride, you must send in a copy of your horse's registration papers with the ride entry. This copy will be returned to you the day of the ride.






