

Congress passes Highway Bill

Trail riders gain \$180 million in new trails trust fund

Recreational trails enthusiasts scored a major victory on Nov. 28, 1991, with the creation of a new trails trust fund that will provide \$180 million over the next six years for trail maintenance, repair and construction. The fund is part of the landmark \$151 billion surface transportation bill that Congress passed before adjourning for the year. The passage of the bill came a day after House and Senate conferees met to pound out differences in their respective bills.

It was a surprise victory for recreation interests as the conferees accepted provisions contained in the Senate highway bill to create a new national recreational trails fund. The trails

legislation was championed by U.S. Senator Steve Symms (R-ID), and strongly supported by the American Horse Council (AHC) and the American Recreation Coalition's Trail Task Force headed by Roy Muth of the International Snowmobile Industry Association.

"This is a great victory for the equestrian trail-riding community," said R. Richard Rolapp, president of the AHC. "Not only does this legislation provide much needed funds for the repair and maintenance of trails which benefit horseback riders, but it also creates a national

advisory committee which will include an equestrian representative." This marks the first time the equestrian community has been directly represented in determining the national trails policy.

The new trails fund will provide some \$30 million in grants annually for six years. Moneys for the grants are derived from the federal excise tax collected on fuel used in non-highway recreation, including snowmobiling and

trailbiking. All trail enthusiasts will benefit from the fund. Of the \$30 million provided each year, 30 percent will be spent on the repair and maintenance of strictly nonmotorized trails and 40

percent on trails that allow for two or more compatible uses. The remaining 30 percent of the money will be dedicated to maintaining and repairing motorized recreational trails.

A few amendments were made to the final version of the legislation, including a provision to have the fund administered by the Secretary of Transportation in consultation with the Secretary of the Interior and to extend the program from four to six years. – American Horse Council, Dec. 3, 1991


Which was your first NATRC ride, and in what year?




What do you like best about NATRC?

Far and above the most popular answer . . . the friendly people, followed by the beautiful scenery, especially from horseback, and enjoying new areas and trails. The educational aspect toward better horse care and horsemanship was rated right up there. The friendly competition was ranked high too, along with meeting new people with the same "horsy" interests. Other respondents wrote they enjoyed camping, dedicated judges and ride organizers, helpfulness of other competitors, the rides using themes, the fun

of conditioning the horse beforehand and meeting a need not met by other horse activities at a reasonable cost. A few disciplined riders wrote they appreciated the structure and control of the rides.

How would you like to improve our rides?

More regard to the novice aspects; timing, obstacles and safety on the trail. A few hard-core riders want tougher open trails. Some think a couple open riders out there shouldn't take themselves so seriously. Many riders would like more rides with themes. Briefings should be informative but short. Punctual judges and more out-of-region judges. A few respondents think that favoritism has been shown to regular riders. Set standardized and consistent scoring in judging systems. A couple members think there is too much emphasis on manners. Improve the time it takes to tabulate the scores on Sunday afternoon, maybe by starting riders earlier Sunday morning? Many riders like the idea of name tags for everyone, and some people think they would like to get the overall ride results mailed to them. And at least one of you out there thinks there aren't enough girls at the

Jan Murphy on trail to recovery

or those of you who may not know Jan Murphy, she was active in competing a couple of years ago and was nearly killed in an auto accident in August 1990. She spent several months in the hospital and since has been in therapy re-learning many skills.

Jan could never have come as far as she has without her husband John's support. A non-horse person, John recognized Jan's need to be with her horses as a strong motivation for her to recover. So, in addition to taking over running the house and the many tasks involved on their property, he took over the horse care. He arranged for veterinary care for Jan's horse Raider, who was injured in the same accident. When Raider was sound again and Jan was at home, John encouraged her to ride, and rigged up a ramp so she could get on her horse. He trailers Raider and another horse, Zeb, so Jan can ride with her friends and he has learned to groom and tack the horses. He is not afraid to ask for advice or help – anything it takes to help Jan.

Jan's companion Debra is great too. Though she'd never been on a horse before, she's taking riding lessons and accompanies Jan on Zeb when they trail ride. She is a delightful, soft-spoken woman who always goes the extra

mile in her efforts.

Finally, there's Raider. The eight year old half-Arabian gelding that Jan raised, patiently stands in cross-ties while his rider is helped up the ramp and

onto his back. His steps are slow and careful. Jan has very limited use of the right side of her body and Raider has adapted beautifully

Because she wants to ride so much, Jan's making progress. Her dressage teacher confirms that. Disqualification can result

An excerpt from the national board minutes (Riders Committee) states the biggest problem at this time are competitors leaving rides before awards without obtaining permission from judges and ride management. The rule book explains that horse and rider remain in competition until such time as they are disqualified or public announcement of awards is completed. Only in extenuating circumstances may both judges and management together give permission for a horse or rider to leave prior to the announcement of awards. The book goes on to state that in the event awards are not presented by 9:00 p.m. on awards night, horse and rider will be allowed to leave the ride and awards will

Don't let an unfortunate thing like disqualification happen to you. You made it to the ride (in some cases a several-hours haul) and then rode in snow and rain or heat and dust. You're tired and maybe even crabby, and ready to head for home. Don't throw all your efforts away by not following the rules.

NATIONAL BOARD HIGHLIGHTS

Minutes from the national Board of Directors (BOD) meeting, Nov. 9, 1991 in San Antonio, Tex.

New board members recently elected were: Reg. 1 - tie to be decided in runoff; Reg. 2, Ron Watson; Reg. 3, Dean Schrader; Reg. 4, Michelle Glover DVM; Reg. 5, Judy Jesse; and Reg. 6, Jackie Coleman. Total membership 1,866. Regional breakdown: Reg. 1, 406; Reg. 2, 239; Reg. 3, 269; Reg. 4, 339; Reg. 5, 395; and Reg. 6 218. This is down from last year at this time.

From the Judges Committee: Question regarding use of electric massager on horses during ride. The committee felt this was in direct violation of rule book (page 6, Sec. IV, C5) which states, "Oral supplements of salt, electrolytes . . . No other medications, ointments, braces, dressings, drugs, ice, bandages or other artificial (unnatural) remedy may be administered during the ride . . ." Judges Committee felt that an electric massager is definitely an artificial aid. Committee felt that heart monitors are OK since no advantage is given to rider using monitor as opposed to one using stethoscope. Awnings were also discussed and deemed allowable since it could be considered the same as finding a parking spot with the shade of a tree. However, the use of awnings would be left up to the presiding vet judge at the ride.

From the Riders Committee: Most pressing problem at this time is riders leaving before awards without obtaining permission from all judges and management. Riders need to know that leaving without notification and permission could result in disqualification. Suggestion that an announcement be made on Saturday night regarding this.

Please contact any of your Region 3 national board members with ideas, comments, changes or improvements you would like to have taken before the national board. The next national board meeting will be Thurs., Feb. 20, 1992 in San Jose, Calif.

From the Management Committee: Discussion on change for BOD guidelines regarding elevating from a type B to type A ride. Motion made and approved that riders may elevate from type B to type A ride provided the change is made immediately after crossing the finish line and that both B ride and A ride are judged equally by the same judges.

Horse Hall of Fame: Barthart, owned by Betty Young was voted on and approved.

Rule changes: Extensive discussion regarding possible changes in eligibility to compete in novice. Some board members felt that it was important to let riders continue to compete in novice after starting the ride year regardless of wins accumulated. Proposed rule change failed, but board clarified that each region is free to determine how year-end awards would be decided for novice division.

Rule on HDC entries clarified. Page 5 Sec. III, C1. Horses and/or riders participating in HDC for any reason will be judged in all ride activities as are other competitors, but will be eligible for mileage only. In limited rides, HDC entries will not displace regular entries from competition in the ride. Ride management must make an effort to notify any HDC entries that they may not be able to participate in the ride. HDC horses and riders will not count as competitors in the class. Page 16, Sec VI, C: Change wording to: Point distribution – HDC or disqualified horse and rider receive no points.

New committee formed to review criteria for President's Cup; Region 3 board member, Dean Schrader, will be on the committee. - Laurie Butterfield

REGIONAL BOARD HIGHLIGHTS

The following is an abbreviated version of the minutes of the general assembly held prior to the board of directors (BOD) meeting, Nov. 2, 1991, at the Red Lion Inn, Durango, Colo.

National Appreciation Award nomination; Judi Tobias

was nominated, then elected by oral vote.

Sue Breytag Award; several nominations, Sena Fitzpatrick and Don Grieser elected by BOD and general membership by ballot.

Ariel Schrader suggested the purchase of a tent to be used at every ride for management and shelter in inclement weather. Discussion followed about possibly renting back to ride management to recoup costs. Ariel will bring more information to next BOD meeting in January 1992.

Jim Porter suggested a PA system for ride management use. He will bring more information to January BOD

meeting.

Judy Cumberworth brought to attention a problem with Cherry Pitts ride results and to what year placings should be credited. Discussion followed about extending year-end awards, longer ride season, horses growing winter coats and then competing in a warmer climate. Tom and Barbara Butterfield may move their ride forward, possibly the "Cherry rides" could move up or be held in the spring depending on Rabbit Valley schedule.

Dean Schrader mentioned he has been questioned about safety riders' horses being included in P&Rs. Pat Jubb suggested that safety riders' horses be designated as such so there is less confusion at trailer checks. As a veterinary judge, Joe Quintana thought he would not be able to check more than 60 animals. Patti Embree thought P&R and safety riders should be educated about having their horses in shape and to keep track of how they are holding up. She also thought they should carry stethoscopes to check their mounts. A suggestion was offered that maybe the ride management should screen the mounted ride helpers and Jill Talbot thought maybe a safety rider chairman was needed to keep track of this. Will continue discussion at January meeting.

Dean Schrader brought up suggestion about asking judges in our region to judge no more than two rides in same region. Discussion followed about costs for bringing in local judges versus ones that would have to travel some distance. Joe Quintana advised that judges should be asked

to self-regulate themselves.


Morgan horse found in wide range of activities

First all-American breed ranges from backyard pony to police horse and more

He Horse that built America," "The versatile breed" and "The pride and product of America," the Morgan is all of these things and more. They are as spirited as the pioneers that bred and used them to clear the wilderness.

All Morgans trace their lineage to one stallion, bred in the early days of a new nation ... the United States. Justin Morgan's antecedents remain shrouded in some mystery but his descendents, even some 200 years later, have been welded into a breed whose fame as all purpose horses has grown stronger. Morgans excel as family ponies, hunters, roadsters and endurance horses.

In the early days, the fame of Justin Morgan was spread through his sons: Sherman, Bulrush,




The U.S. government recognized the Morgan's endurance and vigor and established the U.S. Government Morgan Horse Farm.

When war divided the nation, the Morgan was enlisted as the foremost mount of the U.S. Cavalry. Every general on both sides chose to ride Morgans into battle. The U.S. government recognized the Morgan's endurance and vigor and established the U.S. Government Morgan Horse Farm which maintained an exclusive Morgan breeding program until the 1950s. It was then purchased by the University of Vermont and flourishes today as a major

breeding establishment.

Today's breeding has taken the Morgan into two basic directions, the "old" and the "new." The "old" consists of breeding following the traditional type, short-coupled, thick neck and compact muscles. The "new" is usually taller, longer-coupled and less "typey." These two types lend themselves to the diversifying of the Morgan's capabilities.

Today, the Morgan is represented in a diverse network of equine activities from the show ring to trail and working ranches. Morgans are used on several metro police forces, including the U.S. Park Police, attracted to Morgans for their level-headed, good natured dispositions and athletic ability. Morgans have tremendous personality that improves with attention. With their beauty and conformation they always seem to stand out in a group. – Thom Harris, Foxton Morgans



characteristics which were used to improve the horses to which they were bred. During the early years, breeders were not so concerned with the type as with Morgan aptitude. They outcrossed to cold blood for farm teams and to Messenger blood for trotting speed. Important characteristics passed on were compactness of form, high and generous spirit combined with gentleness and tractability, along with lofty style and easy but vigorous action. Justin's son, Revenge, was bred to a mare that had a tendency to pace. Her dam was thought to have a bit of Narraganset Pacer blood which would account for the tendency to pacing and mixing gaits, and with the "running walk" in some Morgans.

Morgan blood can be found in numerous breeds. Through the great-grandson of Justin, the early American Saddlebred gained much of its beauty and ability. Some of its greatest names trace back to Morgans. In the days when road

Sweepstakes Commission vote in favor of joint competitive trail/endurance funds

Ron Palelek, Sweepstakes Commission chairman of the International Arabian Horse Assn. has announced that the commission voted favorably to accept the joint competitive trail/endurance proposal of Nov. 22, 1991. This proposal called for re-allocation of sweepstakes funds for distance riding competition.

Effective Jan. 1, 1992, the sweepstakes payout will be combined for both purebred and half-Arabians at both regional and national levels. Monies allocated at the regional level are: Champion, \$1,000; Reserve Champion, \$500; and remaining top three, \$250. At the national level: Champion \$5,000; Reserve Champion, \$2,500; and remaining top eight, \$525. The gelding incentive of 25 percent remains unchanged. – Neal McKinstry

BITS AND PIECES

Region 3 renewal/newsletter subscription

If you haven't renewed your Region 3 membership, the cutoff date for receiving the *Region Three Newsletter* will be June 1 of the same year. National (but not Region 3) members will receive two complementary newsletters only unless they join Region 3.

Ride critiques

The national board of directors recently voted to discontinue the ride critiques. Any comments can and should be directed to Region 3 board members, national board members or Gloria Becker at (619) 58-TRAIL.

Eligibility for Region 3 year-end awards

All national NATRC members who are dues-paying members to Region 3 NATRC are eligible for regional placings and awards.

Requirements:

Open horses and riders must enter three (3) rides per season and accumulate a minimum of 30 points to be eligible for year-end placings. Open horses and riders will be eligible for the Ruth Tyree High Average Horsemanship and Ken Burkdoll Combined High Average Horse/Rider awards if they enter a minimum of six (6) regional rides. All rides started will be counted.

Competitive Pleasure horses and riders must enter two (2) rides per season and accumulate a minimum of 20 points to be eligible for year-end placings. Competitive Pleasure horses and riders will be eligible to compete for the High Average Combined Horse/Rider award but must enter a minimum of four (4) rides per season. The top horse in Competitive Pleasure shall be considered as a sweepstakes horse within the class and shall receive 2 additional points as done in the Open and Novice divisions.

Novice horses and riders must enter two (2) rides per season and accumulate a minimum of 12 points to be eligible for year-end awards.

Horses and riders receive 4 points for ride completion and a sweepstakes horse receives 2 points (18).

Memo to ride managers

Rides are requested to send the results of a ride to national within two weeks after the ride. Ride results and Region 3 rider fees should be sent at the same time to the supply chairman.

Verification of points and mileage

The point secretary keeps all Region 3 members' points and mileage each year. You are welcome to verify your points with the chairman by Oct. 15 of the current year, otherwise you must accept the points as calculated by the point secretary. Region 3 NATRC members who have not renewed their memberships by June 1 of each year will have to pay an additional \$15 secretarial fee if they wish to have either their horse or rider points and mileage recorded.

Dear Editor,

I would like to extend my heartfelt appreciation to some special individuals within Region 3 who came to my aid last October during the Cherry Pits ride in Farmington, New Mex.

My "new" gray Arabian mare, STF Tiffany Bay (Shura) showed signs of colic immediately after I unloaded her at the ride, so I took her over to Dr. Joe Quintana who was the ride vet, to be checked. He observed her and then called one of his partners, Dr. Boyd Edmond, of Animal Haven Clinic, who tubed her and gave her pain shots. She was diagnosed as having a positional foal colic (she was due in April). Shura seemed better but then got worse in the evening and Joe administered further treatment. I stayed with her through the night. Calvin Reed let me put her in one of the barn stalls. She was quiet until about 3:00 a.m. when I ran for Joe in his camper. At that point, we loaded her and hauled her into town where Joe and Dr. Edmond performed surgery on her. Through the next two days, she would seem to improve but then grow worse, eventually aborting the foal. She was taken into surgery again on Sunday afternoon and did not survive. A portion of her intestine had lost blood circulation and could not be repaired – old bloodworm damage.

Although it's still very difficult for me to accept my mare's death, I know that Dr. Quintana, Dr. Edmond and the staff of Animal Haven Clinic did everything possible to save her life and to minimize her suffering. Dr. Edmond seldom left the clinic while she was being treated and promptly returned every few hours like clockwork to a sick mare and her distraught owner. He was incredibly kind and gentle to Shura every time he worked on her. Dr. Quintana judged a ride on almost no sleep and came directly to the clinic on Sunday after the ride, to perform yet another surgery.

Furthermore, both vets and the staff at Animal Haven Clinic made this very difficult experience bearable to Shura's people family – Don, Jason and myself, as well as to her equine friends, Indy and Windwalker who were brought to the clinic after the ride was over. We literally camped out in the barn and parking lot of Animal Haven Clinic that weekend.

Additionally, I will be forever indebted to two fantastic human beings – Bill and Jenny Smith. They came by the clinic on Sunday afternoon after they found out we were still there, and asked what they could do to help, if anything. The "anything" became finding a way to help transport a dead horse to Pine Hill, New Mex. Bill immediately drove home and picked up a flat bed trailer and tarp, and helped load Shura onto it. Jenny drove my mare home the next morning. Shura now rests on a hillside next to W.B. Auspicious.

I also want to thank all the people who demonstrated their kindness during this experience through words or cards. It has really meant a lot to me.

National suggests a change on 5-win rule

Region 3 will test for one-year period

Region 3 will undergo a one-year trial period to consider the national board recommendation of an adjusted Novice division 5-win rule. According to a statement from national, read by Laurie Butterfield at the Region 3 January board meeting regarding the 5-win rule: Any horse and rider combination having won 5 firsts in horse regardless of division or class shall not compete for awards in Novice horse division.

(Add) For one year only and for regional awards only, each region may allow placing points for each HDC Novice horse/rider equal to the score of the nearest placing horse/rider. Four-year old horses exempt. Region point secretary will place each HDC horse in accordance with scoring indicated on the verified ride reports. Any region can use this system.

The Region 3 board agreed to try the adjusted rule using national's guidelines. Complete information will be available in the Spring 1992 issue, in the regional board highlights. This trial will apply to Junior riders also.

Your Horse's Minimum Daily Requirements

- Adequate fibrous feed. Hay and grasses, not unpalatable noxious weeds.
- Adequate, reasonable clean water. Thirst kills more quickly than hunger.
- A salt lick.
- Shade and shelter.
- Exercise.
- Companionship.
- Protection from parasite overload (deworming).
- Functional feet.


