## Colorado Trail receives NATRC repair work

**O**n Aug. 5, Kathryn Utke and Marguerite Porter drove up to Copper Village to scout out Section 12 of the Colorado Trail – the portion that Region III has adopted. The trail begins

at Copper Mountain Village ski area and winds for nine miles, going up above timberline. It follows a creek dotted with beaver dams and waterfalls. The wildflowers are always beautiful up there too! That

evening, Neal McKinstry showed up with two horses to help pack equipment back into the trail.

The following day, Calvin Utke, Jim Porter, Karen Moe and Steve Trolander arrived to pitch in with the trail maintenance. As those four hiked the trail, Kathryn, Marguerite and Neal rode horseback. Some fallen trees blocking the path were removed, but the “main event” was repair work done on a boggy area about 5 feet by 15 feet. This task took up a major part of the day. As they worked, they encountered bicyclists and hikers who were very appreciative of their efforts.

It was important to the workers to inform other trail users that equestrians – and especially NATRC – are putting forth the time, effort and commitment maintaining trails, not just riding on them.

## LETTERS

Dear Region III Newsletter,

I enjoyed the article on Rider Responsibility by Judi Tobias. I have put myself or my horse in a few of these scenarios, either through ignorance or poor judgement. But, I do wonder what the judge's or ride management's responsibility is in the case of a horse ridden too hard with a lost shoe, resulting in lameness and hoof damage.

Section V. Judging - Paragraph E - Disqualification - Lines 1 & 3 would permit such a rider to be disqualified from receiving completion points, mileage or an award. "Riders who abuse their horses" and "Riders who engage in conduct unbecoming a competitive trail rider" shall be disqualified. I feel vet judges should consider the final check out to be one last chance to pull a horse that is unfit to continue rather than just another opportunity to deduct points.

Thank you for the opportunity to express an opinion and to quote the NATRC rule book.

## Horse Stories ...

### Ode to Par Torpedo

**W**hen I bought my Arab two years ago, I remember the owner telling me that this horse will be a wonderful companion with a kind disposition. It took me awhile to bond with him because of a barbed-wire injury that occurred two months after I bought him – it took a long time to heal.

We began to prepare for the '93 season and due to shoeing problems and some slight lameness, it discouraged us from pursuing any further rides that year. That was okay. I headed for the mountains, put a lot of miles on him and got to know my horse. He was incredibly mellow and kind, and really seemed to enjoy himself on the trail. I'm not saying that Torpedo hasn't had his "Arab moments" as his name implies. We spent the entire year conditioning and conditioning. We were ready for 1994! I looked at the beginning of the season optimistically and was anxious to be back in the saddle again. My goal was to compete and complete the ride season in the Open division – a task that seemed in prior years to defy me.

I was in shock the first three rides when Torpedo took three second-places. One of the rides – Rabbit Valley – he finished with 99.5%, losing to a 100% horse with a whole lot more experience. We ran the whole gamut this year from numerous second to sixth places, racking up 87 points and about 500 miles. No National Championship this year. We would have had to score a 100% perfect to get one – it just wasn't in the cards.

I could never say that I was disappointed, because it saying that I would be saying my partner didn't try his best or had let me down. We went up against horses this year that have been in this sport for years – decades, even – against Hall of Famers, President's Cup winners, National Champions, and beat them. In my eyes, he is the 100% I have been looking for and it doesn't get any better than that!

Besides, there is always another year to compete – take it from someone who knows! Here's to you, Torpedo!



## *A helmet story ...*

They had just passed the first P&R and obstacle Sunday morning. It was a lovely September day in the Colorado mountains. The horses were in fine form as Carol Fredal and Peggy Redle followed the trail at the Golden Gate trail ride. They were discussing the obstacle. Without realizing it, they took a wrong turn and were off the trail. As they descended a hill, Carol felt her mare become tense. The horse began to lunge wildly. Carol couldn't see an old barbed-wire fence hidden in the leaves and underbrush. Her mare had caught its feet in the wire and was frantically trying to get free. Off-balance, Carol pitched forward and landed under the animal. Several times, the hooves struck her – at least twice in the head – before the horse broke free and bolted off down the trail.

Dazed, Carol managed to get back up the hill. There, back on the trail, she encountered safety riders Tom Dines and Clark Eaton. She and Peggy related the story. Carol was more worried about the horse than herself. After checking her over, Tom and Clark took her to a nearby campground where Clark stayed with the horses as Tom got a vehicle to take Carol back to camp.

Back at camp Tom Kabel, an EMT, stayed with Carol while ride manager Jill Hicks made arrangements to get help for Carol and inform the park rangers about the missing horse. Meanwhile, Tom and Clark went back and continued on the trail, informing nearby landowners about the mare. The park is in an area with no motorized access, so mounting a search wasn't feasible.

Carol was taken to a nearby hospital and found to have only bruises. She and her husband Dan went home to Monument, Colo., to wait for word on Carol's horse. On Monday, they were planning a horseback search, when the animal was found and returned to a relieved Carol with only minor cuts.

The main reason this story has a happy ending and that Carol is alive and well is that she was wearing a helmet. She and Dan never ride without them. They are both well aware that had she not have been wearing her helmet the kicks she received could well have been fatal. – *Judi Tobias*





## BITS AND PIECES

### Region III renewal/newsletter subscription

If you haven't renewed your Region III membership, the cutoff date for receiving the **Region 3 Newsletter** will be June 1 of the same year. National only members will receive two complementary newsletters unless they join Region III.

### Eligibility for Region III year-end awards

All national NATRC members who are dues-paying members to Region III NATRC are eligible for regional placings and awards.

Requirements: Open horses and riders must enter three (3) rides per season and accumulate a minimum of 30 points to be eligible for year-end placings. Open horses and riders will be eligible for the Ruth Tyree High Average Horsemanship and Ken Burkdoll Combined High Average Horse/Rider awards if they enter a minimum of six (6) regional rides. All rides started will be counted.

Competitive Pleasure horses and riders must enter two (2) rides per season and accumulate a minimum of 20 points to be eligible for year-end placings. Competitive Pleasure horses and riders will be eligible to compete for the High Average Combined Horse/Rider award but must enter a minimum of four (4) rides per season. The top horse in Competitive Pleasure shall be considered as a sweepstakes horse within the class and shall receive 2 additional points as done in the Open and Novice divisions. Novice horses and riders must enter two (2) rides per season and accumulate a minimum of 12 points to be eligible for year-end awards. Horses and riders receive 4 points for ride completion and a sweepstakes horse receives 2 points (18).

### Memo to ride managers

Ride managers are requested to send the ride results to national within two weeks after the ride. Region III rider fees should be sent at the same time to the point chairman.

### Verification of points and mileage

The point secretary keeps all Region III members' points and mileage each year. You must submit your own horse/rider mileage to the national mileage chairman for national NATRC records. Please verify points (after figuring your own, first) with the chairman by Dec. 1 of the current year, otherwise you must accept the points as calculated. Region III NATRC members who have not renewed their memberships by Mar. 1 of each year will have to pay an additional \$15 secretarial fee if they wish to have either their horse or rider points and mileage recorded. ### Breed award eligibility

To be eligible for breed awards at each ride, a copy of your horse's registration papers must be included with the ride entry. The copy will be returned to you the day of the ride.

### Computerized membership mailing labels offered

Joyce Calhoun has the responsibility of the mailing labels various Region III activities. Her database can be categorized by districts, zip codes and includes people who have ridden in the past two years. They can be helpful to solicit participants for Region III NATRC events. Note to ride managers: Submit requests for rider lists with ample time for Joyce to prepare them, not at the last minute, please! The fee is \$5. Contact Joyce Calhoun at 761 W. 
